Sealed Tenders based on MRS 2nd Bi-Annual-2021 item rates/ percentage above or below from approved estimated amount are hereby invited for the work mentioned below from the approved contractors / firms enlisted / renewed with C & W department for the current financial year in the field of building works.
2. Tender Documents can be obtained from the date of publication i.e., 03.11.2021 of invitation to bid on PPRA website from the Institute/ office upon written request on the firm's letterhead accompanied with **payment evidence of prescribed tender fee** during office hours. No tender will be issued in absence of above relevant documents and no excuse what so ever will be accepted.
3. The Tender fee Rs.1000/-(**Non-refundable**) will be deposited in Bank of Punjab Model Town branch Rahim Yar Khan (Branch Code 0023) in **Non-Salary Bank Account No. CPA 6580098726900148** and deposit slip will be attached with tender issuance request.
4. Tender rates and amount shall be filled in figures as well as in words and the tender shall be signed as per general direction given in the tender documents. In addition **attested copies of enlistment, up to date renewal letter, PEC license, CNIC of Contractor/ Managing Partner/ Director of the firm along with power of attorney and 2% bid security as captioned below in shape of CDR must be attached with tender documents.** No amendment / change in Tender rates will be entertained.
5. Sealed Tenders must be received in the office of the Principal, Govt. Technical Training Institute, Thalli Road, Rahim Yar Khan as per below mentioned date & time and will be opened on fixed date and time by the respective District AR/SR Committee of TEVTA at the same venue in the presence of intending contractors or their authorized representatives who choose to be present.
6. Successful bidder will bound to deposit 10% performance security of the contract amount before issuance of work orders or same will be deducted from his total payable bill and return after specific period with subject to the satisfactory performance report. **Additional performance security** as per below quoted rates will also be charged in case of rates quoted more than 5% below by the contractor from the tender estimated amount.
7. Other term and conditions can be seen in the tender documents. Tenders which will not fulfill the conditions laid down in the Tender Notice & Tender documents should not be considered even though it may have the lowest rates. AR/SR Committee shall have the rights to reject any or all bids or proposals at any time prior to acceptance of bid or proposal and shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
